Insurance claim and complaint filed with Indiana Regulatory Commission against Indiana Michigan Power.

G. Natural Gas Consortium meeting on December 1, 2016. RSSC belongs to the East Indiana Natural Gas Cooperative consisting of 32 school corporations. The Consortium agreed to hedge 90% of natural gas purchases from April 2017 to March 2021. This will lock our price in at approximately \$3.03 per dekatherm and allow us to budget a more fixed amount.

H. School Corporation received tax settlement on December 7th .

Debt Service = \$228,998.88.

CPF = \$238,741.24.

Transportation = \$163,578.34.

Bus Replacement = \$48,552.17.

** The audit conducted in May 2016 by the State Board of Accounts costs \$7,796.00 and was charged to the Transportation Fund.

I. School Corporation will pay off the 2013 Renovation Bond by December 30th with a final payment of \$171,700.00.

The School Corporation will pay off the Tax Anticipation Warrant of \$172,474.73 (CPF) and \$94,602.36 (Transportation) by December 30th.

The School Corporation will pay the semi-annual lease payment for the 2009 bond of \$181,625 by December 30th.
