II. MAY 2017

Pat Tillson made a motion to approve the minutes of the regular board meeting held April 10, 2017 as presented. Eric Retter seconded the motion and motion carried 4-0.

V.A.MAY 2017

Patricia Tillson made a motion to approve the Accounts Payable Vouchers 297-398 as presented for General Fund; Capital Projects; Transportation; Go Bond 2016, Formative Assessment Grant, Career and Technology Perf, High Ability 2016-17, Title I 16-17, Special Education 16-17, Title II 16-17, Clearing, and Payroll. Eric Retter seconded the motion and motion carried 4-0.

General Fund Cash Balance as of April 30, 2017 was \$579,184.56. The cash balance is the highest it has been in 19 years. This balance does not reflect the payment to Cowan for the Speech & Language Pathologist of approximately \$40,000. At this time Cowan has not submitted the invoice.

VI.A.11.MAY 2017

Patricia Tillson made a motion to approve a Summer Food Service Program as presented by Food Service Director and Superintendent. The program would be available beginning June 5 and run through July 21, 2017 at the Jr./Sr. High School from 11:00 AM to 12:30 PM daily with a satellite site at the Washington Twp. Public Library on Tuesday and Thursday from noon to 12:30 PM. All children under 18 would receive the meal at no charge and all those 19 and over would be charged \$3.50 per meal. The State will reimburse for all meals served to those 18 and under. Estimated expenses are \$7,000 for labor and \$10,000 for food costs. The labor costs would be for three staff members paid at the regular rate of pay on an average of 3.5 hours per day and supervisor paid for up to 5 hours a day. Eric Retter seconded the motion and motion carried 4-0.

VI.A.12. MAY 2017

Eric Retter made a motion to approve the Student Teacher Agreement between Randolph Southern School Corporation and Ball State University. There is no cost to the school corporation. Tom McFarland seconded the motion and motion carried 4-0.

Eric Retter made a motion to approve the Lease Agreement with Bryan W. Martzell and Jasmine I. Martzell for the property due east of the Jr./Sr. High School Building and next to the baseball diamond for \$350.00 per year beginning on June 1, 2017 and ending May 31, 2018. Any excess topsoil may be sold at a later time.
